August 2, 2007

2. Officer Activity Report #2 now includes a Citation Ticket Count. Changes have been made to both Officer Activity Reports and these changes have been reflected in the 'Help' Section.

July 31, 2007

1. Updated Collection Report to differentiate by Court-ID.
2. Merchant Fix in place for any court having Merchant/Hot Check issues. Call HCSS after you update and we will help you run the fix.
3. Flags on People Record Inquiry/Update Screen now in bold red font.

July 24, 2007

1. Child/Parent in Juvenile Cases were listed incorrectly and have now been fixed.
2. 'Filed By' now lists all record types.
3. Added Adobe 8.0 Professional compatibility to IADT.
4. Calendar 'Delete Party' fixed.
5. Calendar System Event List Screen's 'Next' and 'Previous' Button fixed.

June 26, 2007

1. Scanned Image list glitch fixed. The scanned images were excluding images with the same relative name that had been created within the same minute.
2. All Court Reports updated to new format. This new format includes on-screen step-by-step instructions as well as an example report link.
3. The Merchant Cause-List screen would not list out the cause records for specific merchants – this has now been fixed.
4. Report Help section has been updated to reflect the Reports section updates.
5. Record Archive Status Report fixed.
6. Code Record Listing Report includes Condition Codes now.
7. Improved Scanned Image List Screen Efficiency.
8. Added 'Settings' type to Cause Docket Civil Report.
9. Added Offense Description to Status List Report.

June 4, 2007

1. All of the online help screens should be current, or at the very least, close to being current.
2. On the "Extended Search Specifications" (People Search) screen, the dates now display properly.
3. Employer record screen displays have been changed to be in the same format as a merchant record, minus the hot check information.
4. The tab sequence on the citation screen has been modified and your flow of data entry should now go smoother if you use the tab key. There have also been some other cosmetic changes made to the citation screen.
5. The multi task control buttons, were omitted from the civil style cause display screens. This situation has been corrected.
6. Civil style causes, when added to the calendar for scheduling, were not automatically adding all of the parties involved, to the event. This situation has been corrected.
7. There were some cosmetic modifications made to the merchant display screen.
8. In the "sentencing process area" there is a screen to enter "Extended Statistics". This screen needed some major assistance and I believe you will now find it much easier to use. Also, some of the dates associated with the sentence were not displaying properly. This situation has also been resolved.
9. On the court information screen, an automatic primary contact person indicator has been modified to properly represent the type of court. This modification was to distinguish between judges and clerks.
10. When using the calendar to schedule events, one of the parties involved is the designation of a judge to hear the case. Since most of our courts are small courts and only have one judge, we have been asked if we could not assign the judge automatically when the cause is initially entered into the system. Keeping in mind that over the years judges will change, and when they do change we can not delete the old judge's record, I have implemented the following: I have added a field to the inquiry/update screen for the judges which will allow you to designate the four letter abbreviation of the court to which this judge is to be the default judge. For example "JPCT", "DCRT", etc. Once you have done this the program will automatically assign this judge to all causes entered. You should only have one judge designated for each court. If you designate more than one judge for a court, the program will use the first judge it finds with that indication.
11. We have removed the plea option from the "Enter Amount to be Paid" screen for civil style and inquest causes.
12. We have modified all of the report control screens to a new format which we believe will make the processing of reports much easier to do.

May 29, 2007

4. Certification and Notes now reflect visual layout when printed.

April 03, 2007

1. OMNI warning put into place to prevent bad transmissions.
2. Persons no longer able to be saved as type 'all'.
3. Automated Time Payment now triggers Status Print Control.

March 29, 2007

1. Docket Call List Landscape Criminal now has Status selection option.
2. Electronic OCA file fixed for JP and MUNI courts.
3. Citation Date now comes across during Multiple Cause Creation

March 27, 2007

1. Docket Call List Landscape Civil now has a Status selection option as well as aesthetic changes to the printout.
2. Convenient recalculate buttons added on money screens.
3. Warning put in place for defendant cause listing report.

March 26, 2007

1. Incorporated batch processing for Juveniles.
2. Juvenile Inquiry/Update screen now shows case type.

March 22, 2007

1. Scan EDR codes now functional for all courts.
2. Cause Record List screen buttons realigned.

March 15, 2007

1. Disabled ability to save record type as 'All'.

March 13, 2007

2. Omni Transmission Screen 'Initial Transfer' Removed from user access.
3. Death Certificate Panel Correction.
4. Adding a new document in the Wordperfect Merge Screen now has 'Next Page' fix.
5. Credit Card and Transfer added to Probate/Civil Panel.
6. Certification is now functioning within reports.

March 6, 2007

1. Word wrap added to Note Record Print.
2. Marriage Screen Tabs altered for County Court.
3. Wordperfect X3 added.

February 13, 2007

1. The Cred Card/Trnsf has been separated into two different payment types: 'Credit Card' and 'Transfer'.
2. Money Distribution Report and Deposit Listing now distinguish Transfers and Credit Cards.
3. Scanning and documentation is now Adobe 8.0 compatible.
4. If receipt amounts are altered and the user exits without saving or recalculating, a warning pops up indicating such.
5. If an update is completed and Finalization has not occurred, warning occurs.
6. Money alterations/recalculations are now intuitive (ie '6' recalculates to '6.00', '.6' recalculates to '0.60',etc).
